What data do we collect?

VucaCanvas® BV collects the following data:

- Personal identification information: name, email address, organization

How do we collect your data?

You directly provide VucaCanvas® BV with most of the data we collect. We collect data and process data when you:

- Register online or place an order for any of our products or services.
- Voluntarily complete a customer survey or provide feedback on any of our platform or via email.
- Use or view our website via your browser's cookies.



How will we use your data?

VucaCanvas® BV collects your data so that we can:

Process your order, manage your account.

VucaCanvas® BV will NOT share your data with our partner companies.

When VucaCanvas® BV processes your order, it may send your data to, and also use the resulting information from, credit reference agencies to prevent fraudulent purchases.

How do we store your data?

VucaCanvas® BV securely stores your data at data servers in France.

VucaCanvas® BV will keep your survey data for 12 months. Once this time period has expired, we will delete your data by asking you permission to delete your survey data.

What are your data protection rights?

VucaCanvas® BV would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access - You have the right to request VucaCanvas® BV for copies of your personal data. We may charge you a small fee for this service.

The right to object to processing - You have the right to object to VucaCanvas® BV's processing of your personal data, under certain conditions.

The right to data portability - You have the right to request that VucaCanvas® BV transfer the data that we have collected to another organization, or directly to you, under certain conditions.
